APPROVE BANQUET EVENT ORDER (BEO)

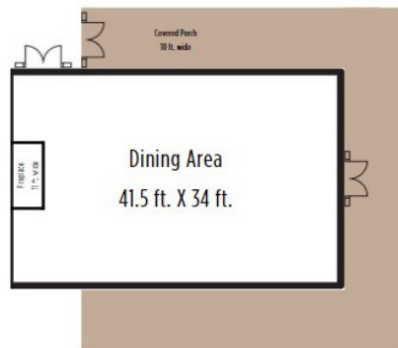

Booking more than one event space can result in a discounted rate.

Our wedding season runs from May - October.

Small weddings under 50 people can be accommodated from November - April.

F A Q ' S

What is the timing for my wedding?

The start time for your ceremony is flexible based on your desired program of events. Amplified music must be turned off by 11 pm with guest departure by 12 am.

Do you allow decorations?

Yes! We welcome decorations, such as flowers, candles, and lighting. We do not allow anything to be applied to the walls or building that will cause damage. If you choose to use candles, we require that they are in containers or on a stand to prevent damage to surfaces or linens.

What type of music is permitted?

Our venues are designed for everything from DJ's to full dance bands. Amplified music is restricted to inside spaces; however, wedding ceremonies may have speaker systems for voice and appropriate music accompaniments.

What is the difference between a Wedding Planner & Venue Coordinator?

The Venue Coordinator is employed by Trillium Links & Lake and is responsible for the day to day operation of our event spaces. They're here to answer any questions about the property, offer suggestions for planning leading up to the day of the event, and then assist your Wedding Planner with the coordination of vendors and events during your wedding at no additional cost to you. The Wedding Planner is hired directly by you and their fee is not included in the price quoted by Trillium. We're happy to offer our approved planner list upon request. Based on your needs, they'll assist with everything from design/color palette selections to caterer selections, floral arrangements, photography scheduling, and many of the other details that make for a seamless and stress free wedding.

REQUIREMENTS FOR MARRIAGE LICENSE

Complete the Online Marriage Application:

- Visit <http://deeds.jacksonnc.org/marriageapplication> and complete the online application before scheduling your appointment.
- Please ensure that all information is fully and accurately filled out to avoid any delays in processing your license.

Schedule an Appointment:

- Appointments are available Monday-Friday from 8:30 am - 4 pm
- To schedule your appointment after submitting the online application or if you have any questions, please call 828.586.7530.

Gather Required Documents:

- **Valid Picture ID:** Driver's License, state-issued ID, passport, or military ID.
- **Proof of Social Security Numbers:** Original card or copy of tax form such as a 1099 or 1040 (must show full name and full social security number)
- **Previous Marriages:** If divorce, annulment, or death occurred within the last year, bring a copy of the divorce/annulment judgement or death certificate.

Visit the Office for Your Appointment:

- Both parties must appear in person
- We will verify IDs and social security numbers
- Sign the license and pay the fee.

Fee and Payment Information:

- The fee for the license is \$60
- Accepted forms of payment include cash and debit/credit cards, excluding American Express.

Additional Information:

- There is no waiting period to get married. However, you must use the marriage license within 60 days of getting it. To make things easier, fill out the online application and schedule your appointment no more than 30 days before your wedding day.

CONTRACTS / POLICIES

TAXES & SERVICE CHARGES:

- Responsible party (hereby know as the Client) agrees to pay Trillium Links & Lake Club (known as the Club) a 20% service charge based on the cost of food & beverage. Responsible party agrees to pay all applicable taxes associated with the event (currently 7%).

PAYMENT:

- A credit card authorization form must be completed, signed, and on file to facilitate payment of any outstanding balance. All CC payments will result in a 3% processing fee.
- Facilities are confirmed for the specified date upon receipt of the signed Facility Usage Agreement and full payment of the rental.
- A \$1,000 refundable tent deposit is required ensuring tent placement and removal meets our guidelines.
- A \$1,000 refundable damage deposit is required to cover potential damages.
- The Facility Usage Fee is non-refundable under any circumstances, and must be paid by check or credit card.
- The client must communicate the final food and bar menus to Management at least four weeks prior to the event date, at which time 50% of the estimated cost is due.
- Upon receiving the guaranteed number of guests 14 days prior to the event (see Guarantee below), the remaining balance for food menus is due 14 days before the event date.
- Selected alcohol package balances are also due four weeks prior to the event date and payment due 14 days prior to the event date.
- Any outstanding balances (bar tab, if applicable) are due and payable by personal check or credit card (with a 3% processing fee) on the day of the event.
- Any outstanding balances remaining 24-hours after the event, along with an additional 5% late fee, will be automatically charged to the client's credit card on file (with a 3% processing fee).

CANCELLATIONS:

- Events that are cancelled will result in a forfeiture of all deposits and/or payments made, and may result in a ban from hosting future events at Trillium.
- Taxes and service charges are not included in the minimum.
- Lack of payment by the appropriate due date may result in automatic cancelation of event.

GUARANTEE:

- The client must communicate the final number of guests to Management no less than 14 days prior to the event date. The number of guests will be considered as a "Guarantee", and final billing will be based on this number.
- Any increases in guest numbers past the guarantee deadline are to be charged an additional fee to compensate for any additional costs necessary. (Fees vary according to price per plate)
- Guests 13 years and older are considered adults, guests between the ages 5-12 years will be charged half price, and guests under 5 are offered selections from our children's menu.

CONTRACTS / POLICIES

- A Client must submit a list of vendors that they deem as 'guest' (partaking in the food and beverage of the event - wedding planner, florist, entertainment, etc.) to management two weeks prior to the event. These will be included in the final guest number guarantee. Trillium requires all vendors to be offered whatever selections are being served to the event guests that evening. If for dietary or other reasons those selections will not work, vendors are responsible for providing their own meal. Please note that we are happy to feed the vendors, but we are here to take care of you, the client, first and foremost.
- Any vendor that is not included in the guaranteed number of guests, but takes part in the event, including food and beverages, will be charged as an additional guest.

RENTAL FEES:

- The Club will not be responsible for any lost or stolen rental items according to contractual agreements between the client and third-party vendors.
- A tent must be reserved for all weddings using the event lawn. If the forecast is 30% or higher a tent is required. The final decision to use a tent due to inclement weather can ultimately be made by the President of Trillium Links & Village LLC 48 hours prior to the event. This policy is in place to protect the integrity of the event lawn and ensure a great wedding experience for the bride and groom. The client is responsible for coordinating with the rental company for an emergency tent breakdown and any additional fees.
- There is a 15% fee of all outside rental invoices as Trillium is responsible for receiving, setting up and returning all rental equipment.
- The tent agreement with the 3rd party vendor must include tent, and other structures on the lawn, setup on the Friday before the event and removal no later than Monday after the event. Failure to do so for the tent or any other structure will result in forfeiture of the \$1,000 deposit. This may incur additional fees if the lawn grass is damaged/killed due to the tent or dance floor.
- If no tent is provided and Trillium needs to provide a last-minute flip of a space or removal of furniture, an additional \$2,500 fee will be incurred.
- The client would need to provide backup generators in the case of power loss due to inclement weather, depending on any vendor's power requirements.
- Trillium requires the appropriate amount of event supplies (chairs, plates, glassware, silverware, generators, etc.). Any moving or flipping of event items or spaces will occur an additional fee.
- Trillium requires a planner/director. If the client does not have one we will provide a day of event coordinator starting at \$900.
- Requires a \$150 per person Food & Beverage minimum and a minimum total event cost of at least \$20,000.

SIGNAGE/DECORATION:

- Signage and decoration used for directing guests may be placed on the property only with prior approval (design and placement) of Management. The signage must be removed within 24 hours of the event.
- Trillium does not provide any signs for events. This is the responsibility of the client, but not required.
- No pictures or wall art may be removed.
- If requested, we will fully clear the mantel.

CONTRACTS / POLICIES

DAMAGE/LOSS:

- Client is responsible for any damage or theft by guests at the Club facilities during the period of time the facility is contracted by the Client.
- Client assumes sole responsibility for personal property including automobiles of guests and/or vendors during the event. The Club is not responsible for loss, damage, or theft of any personal property of Client or their guests and/or vendors at the Club facilities.
- Client and their guests who make use of Club facilities do so at their own risk.
- Client indemnifies and will hold harmless the Club from and against any and all loss, damage, claims or suits arising out of personal injury or property damage caused by intentional or negligent acts of Client or their guest/vendors.
- The credit card authorization form must be completed and returned with this agreement prior to confirmation of the event. The credit card authorization will be used as a guarantee for payment of any damages or losses assessed by the Club during use or any unpaid balances remaining in the 24-hour period following the event.
- Client is responsible for the safety of all underage children (18 years or less) and all actions of all guests as any damages incurred due to intentional acts or negligence.

TRANSPORTATION:

- The Clubhouse and The Landings have limited parking. Client must submit and discuss guest parking, and transportation needs to Management prior to the event. Additional fees may apply for parking attendants and/or for additional transportation needs.
- A 15-passenger van or golf cart will be provided to escort guests from The Clubhouse parking lot to The Clubhouse and/or The Landings.
- If available, a 15-passenger van will be available for pickup and drop off at designated locations within the Trillium property for an additional fee of \$125 an hour and a continued four-hour rental minimum.

SECURITY:

- If Management deems it necessary to secure additional staffing for security or parking purposes, the Client will be required to pay the additional expense. Management will provide an estimate for that service prior to confirmation of the event.

ENTERTAINMENT/BANDS:

- Outdoor entertainment at The Clubhouse or The Landings must end no later than 11 pm, and noise must be kept at an acceptable level per management.
- Management must pre-approve entertainment contracts prior to the Clients signing.
- Client must submit electrical needs, and riders for entertainment/bands to Club (2) weeks prior to the event date.

CONTRACTS / POLICIES

FOOD & BEVERAGE:

- The Club, with the exception of a wedding cake, must provide all food and beverages. Should any guests bring any outside food or beverage into any of Trillium's properties without prior written consent, a penalty can be assessed at the discretion of the Club.
- Food and beverage options are to be selected from our Banquet Menu. Our Food & Beverage Director/Executive Chef are available to help customize menus, and bar packages to meet your specific needs. All Food & Beverage pricing is provided by the Food & Beverage Director, and is subject to change prior to Menu Agreement, Signed Contract, and the receipt of 50% Deposit of Total Estimate.
- North Carolina Health Department codes state that buffets may be available to guests for a maximum of three hours, therefore requests for "to-go" items from the buffet are prohibited.
- Bride/Groom To-Go orders are available by early request only.
- Persons believed to be less than 21 years of age and drinking or persons believed to be intoxicated will be carded, and appropriate action will be taken.
- Management reserves the right to facilitate and comply with all North Carolina ABC Laws by carding, denying service, alerting authorities or closing the bar.
- Illegal substances or drugs are prohibited anywhere on the premises.
- Any outside alcohol brought onto property will be assessed a \$1000 fine, due to our liquor license being in jeopardy.

FACILITIES:

- Trillium Links & Lake Club is a private club. Use of any other amenities or services by the Client or their guests is prohibited unless approved by Management or if such persons have contracted to rent a home within the property. All house guests are required to register with the Office of Member Services or their rental agent and once properly registered will be issued a Houseguest Card.
- Client and their guests must abide by all Club Rules and Regulations, and the Client is responsible for guests' conduct.
- Large gatherings in Trillium homes are not permitted at any time. Clients and guests need to be aware that events booked at either The Clubhouse or The Landings do not include the right to hold "pre-event" or "after-event parties" in any Trillium guest homes (Please refer to your Home Rental Agreement).
- We have the right to require all food & beverage to be served according to N.C. Health Code, and staff safety.
